You probably have received your 2013 NPSD school taxes. Several volunteers have collected and assembled data on recent sales of homes in our township and in the nine communities in Lackawanna County that are also part of the North Pocono School District (NPSD). Using tax ID's and the public tax records online they constructed tables that allow a direct comparison of recent true market values and the school taxes that are assessed for those properties. The data clearly show that similar properties in Wayne County are taxed at a much higher amount than similar properties in Lackawanna County. You could be paying twice as much in school taxes as comparable properties located in the other nine townships in Lackawanna county.

The following is a "Grievance Form Letter" that was sent to residents of Lakeview Estates and includes the tabulated materials. ALL residents, however, are encouraged to send a similar letter to the same addressee to express their concerns to NPSD directly. There is no assurance that this will bring change, but it is a positive influence in the effort to equalize taxes. Increasing demands on school budgets will predictably increase taxes, and the increases should be much greater in Lackawanna County if NPSD is striving for fair taxation. Date
